Hearing of Guests & Special Reports

- 1. Budget Update:
 - a. Approximately \$18,000
- 2. Tech Development Club (Proposed)
 - a. Nathan: Basic idea is to develop Tech and to provide a platform to innovate together and create portfolio pieces and prototypes. Not sure if supplies will be provided to students. Needs to start club and have students vote on projects to propose a budget to the Council of Clubs. A list was passed around to get information for updates from Tech Development Club. Might collaborate with

Business Club to have products sold developed by students, but wants to focus on development, not marketing.

Action Items, Motions, and Other Votes:

- 1 ALT Club
 - a. For nontraditional students. 28 people expressed interest in one way or another. Willamette Hall 218 proposed location. Adult Reentry Programs. Goal is to establish a space for resources (resource center), working with other departments to share resources they offer and to know what's out there, develop networking, share ideas and experiences (camaraderie), create workshop series, and enable follow through. Many have begun school several times, and follow through was the most common problem. Get started and incentivise students with snacks and coffee to stop in and relax; to remember what they have to do and how to complete their goals. Social support will be important. Adviser is Malinda Shell. Reached out to veteran club, joint effort wanted with them. Tomorrow is first meeting. 3-5 proposed dates between now and end of term, will be posted when known. Average age group (25-62) most active folks between 30-45.
 - b. Sam moves to approve initial funds; Travis seconds. Passes 9-0-1
- 2. Council of Clubs By-Laws
 - a. Must show that there is a benefit to funding a trip or activity
 - b. Requests of \$200 or more will be a discussion item at the first meeting, then approved as an action item for the next meeting. Must prove it has benefit.
 - c. Minimum of two weeks, maximum of a month. Important to plan ahead with expenses.
 - d. Raise quorum from 4+chair to 5+chair.
 - e. What ideas are there to ensure we meet quorum?
 - f. Should representatives of more than one club have more than one vote? By-laws will be addressed. Might be too much responsibility to find a representative.
 - g. Will COC meet here same time? Yes, this term. Every two weeks. Might be occasional changes. Diversity Day takes precedence. Clarified--no more than one vote.
 - h. Every club has opportunity to present ideas to be added to discussion items.
 - i. There is a budget form. (will be added to club manual)
 - j. Sam moves to pass bylaws. Travis seconds; passes 9-0-1
